LOCAL PROJECTS

- New Child Care Building – tender to build has been awarded and will be built in the park next to municipal services, across from sport & rec hall.
- Safe House Building – Earthworks tender has been awarded but not the building tender and will be built between the pool and teachers quarters.
- Both are expected to be completed early 2010.
